# NOTICE OF RACE

Translation (Original Version in German is valid)

### 1. Rules

1.1 The event is governed by the rules as defined in the Racing Rules of Sailing (RRS).

1.2 Additionally, the OeSV Racing Regulations, the OeSV General Sailing Instructions, the supplementary sailing instructions of UYCWö, and this Notice of Race apply.

1.3 Unless class rules prescribe or permit otherwise, ISO Standard 12402-5 (or equivalent) shall apply as the minimum requirement for personal flotation devices. The use of inflatable buoyancy aids (automatic lifejackets) is only permitted if expressly allowed in the applicable class rules.

1.4 The Anti-Doping Regulations of World Sailing and the Austrian Anti-Doping Act apply. Athletes and support personnel suspended or banned due to doping are not permitted to participate.

1.5 The use of remotely controlled aircraft (drones) over the racing area by accompanying or support persons is only permitted—besides legal regulations—if registered with and approved by the organizer.



## 2. Advertising

Boats may be required to display advertising chosen and supplied by the organizer. [DP]

## 3. Eligibility and Entry

3.1 The event is open internationally to all boats of the Finn Dinghy class entered in the register of a club recognized by World Sailing, complying with class rules, and holding valid third-party liability insurance.

3.2 All crew members must be members of an affiliated club, individual members of OeSV, or members of another national authority recognized by World Sailing.

3.3 The person in charge must hold an OeSV Junior Regatta License, an OeSV Inland Skipper License (BFA Binnen), a Lake Constance Skipper Patent, or an equivalent foreign document.

3.4 Eligible boats shall enter by completing the online form at [www.uycwoe.at/termine-und-regatten](http://www.uycwoe.at/termine-und-regatten) and transferring the required entry fee to account

no later than 1 May 2026.

3.5 Late entries received before the end of registration will be accepted. A minimum of 15 boats must be entered by the closing date (1 May 2026). Due to local conditions, the maximum number of boats is limited to 70. If this minimum is not reached, the event may be cancelled. If the event is held and a sufficient number of races are completed, the title will be awarded regardless of the number of participants.

3.6 A boat is not considered entered until registration is completed and equipment inspection has been passed.



## 6. Equipment Inspection

## 8. Last Warning Signal

On Sunday, 17 May 2026, if the series is already valid, no warning signal will be made after 15:00.

## 9. Sailing Instructions

Available at registration.

## 10. Courses

Standard courses will be sailed with a target time of 50 minutes.

## 11. Scoring

8 races are scheduled.

1. If 5 or more races are completed, a boat's series score will be the total of its race scores excluding its worst score.
2. If fewer than 5 races are completed, the series score will be the total of all race scores.
3. If fewer than 4 races are completed, the series will not qualify as a National Championship.



## 12. Support Boats

Private support boats are not permitted.

## 13. Berthing

Boats shall be kept in assigned berths.

## 14. Radio Communication

Except in an emergency, a boat shall neither make nor receive voice or data transmissions not available to all boats.

## 15. Prizes

15.1 The winning participant receives medals from Sport Austria and the title "Austrian National Champion 2026 in the Finn Dinghy Class," provided if they are an Austrian citizen.

If the helm is not an Austrian citizen, they receive the title "International Champion of Austria 2026 in the Finn Dinghy Class."

15.2 Prize awards for the first 5 boats.

15.3 Perpetual Trophy

The Finn Alpe Adria Cup will be awarded as a combined ranking of the SP Finn regattas in Trieste (9–10 May 2026) and Wörthersee (14–17 May 2026).

15.4 Participation prizes for all competitors present at the prize-giving ceremony.

## 16. Liability, Media, Data

16.1 Liability

Competitors participate entirely at their own risk (see RRS 3). The organizers and sponsors disclaim any liability for material damage, personal injury, or financial loss occurring before, during, or after the event, except in cases of intent or gross negligence as defined by law.

Claims for damages against race officials and event helpers are waived to the same extent.



#### 16.2 Media Rights

By entering and/or participating, competitors grant the organizer the right to use photographs, video, and audio recordings of them and their boats for reporting and promotional purposes without time limitation.

#### 16.3 Data Protection

Personal data provided may be stored, processed, and shared with higher-level sports organizations for organizational purposes.

#### 16.4 Minors

For minors, consent of the legal guardian is required.

#### 16.5 Miscellaneous

The organization begins well in advance; refunds of entry fees or travel expenses are generally not provided. Refunds may only be granted in exceptional cases and only to the extent of savings made by the organizer (not in cases of force majeure).

Prizes not collected personally at the prize-giving ceremony will be forfeited.

Austrian law applies. The competent court is the court responsible for Maria Wörth.

### 17. Insurance

All persons in charge must confirm that their boat carries valid third-party liability insurance with minimum coverage of €1,500,000 per incident (or equivalent) and provide details upon request.
